All 17 Judges on the NFSS Panel have paid their judge's fees for 2017. Laura is collecting and compiling a list of judging assignments from the Panel. One apprentice - Gene Perez - received approval for final judging assignment.

2014, 2015, 2016 Data bases sorted with corrections made. Website and Awards listings will be corrected accordingly. Revision to Show Classifications - with new Secretary Book - completed and includes new classes for Parrot Finches, addition of old/young classes for pairs, and clarity to Society Finch Section. Completed and submitted 2017 NCBS affiliation form, noting classification changes. These same changes, along with some corrections, will be included in a revision of the Judge's Handbook. Policy being developed regarding protocol for guidance regarding interfering with Judges during judging. Once a draft is complete, it will be provided to Judge's Panel for review and incorporated into Judge's Handbook.

Will work on development of Society Silhouette; photos have been collected to assist with the process. Other standards requested include Violet Eared Waxbill and Purple Grenadier. New standards considered are initiated on the basis of prevalence on the show bench or consistent placements at shows. Discussion will occur with Judge's Panel.
