

# Changes at Save the Gouldian Fund

The Save The Gouldian Fund was formed in September, 2005 as a funding body to support scientific research into the causes of the decline of wild populations of the Gouldian Finch across northern Australia. Under the stewardship of Mike Fidler, Elisabeth Fidler, and Marcus Pollard, the concept of a STGF developed to the point where it now provides significant support for the researchers tackling the problem head-on in the field.

Due to changed personal circumstances Marcus Pollard has resigned from his position as general manager of the STGF. We are very grateful to Marcus for the tremendous amount of time and effort that he put in to turning the STGF concept into the reality that it is today.

With the departure of Marcus, several 'new' faces are now working for the STGF to deliver the desired outcomes.

Arthur Orford, Western Australia, has taken over the role of General Manager. He will oversee the day to day operations of the STGF and to liaise with individual and club donors. Arthur can be contacted by email at: [birdswa@iprimus.com.au](mailto:birdswa@iprimus.com.au)

David Myers, New South Wales, has been named Communications Manager. He will liaise with the various print media publications to promote the STGF and to regularly report on new data coming out of the Gouldian Finch recovery

Chris Baker, New South Wales, will also be heavily involved in the communications area, bringing his artistic talent to the STGF. His work will be seen in many avicultural publications in the months ahead.

Dr Sarah Pryke, together with one of her technical colleagues from Macquarie University, has taken over the role of STGF Web Master. There will be a short delay in website updates as they are currently working on a technology update to improve website performance and navigation. John Butler, one of the foremost names in Australian aviculture, retains the role of STGF Open Day organiser.

## New Initiatives

STGF has recently entered into a joint venture with the World Wildlife Fund that will start within the next two

months. Basically this will see fire cells and their associated controlled burning programs being implemented on properties adjoining Mornington Wildlife Sanctuary for the first time since the Gouldian Finch research started. This is the first major step to restoring the Gouldian in the wild. We will report on this initiative in another article.

Another major development will be the shifting in focus of the Gouldian Finch research program from Mornington to Wyndham. The STGF has just negotiated a 21 year lease with Shire of Wyndham East Kimberley on the old Wyndham Town Hall. This is a heritage listed building which had fallen

into disuse and was currently being used for storage. Our intention is to refurbish and convert this building to provide facilities and accommodation for up to twenty scientists, including two executive suites, laboratory facilities, and enclosed garaging. Upon completion this complex will be known as the Wyndham Hall Science Village. A more detailed report will be provided in the near future.

# Society Finches as Companion Birds

Some bird folks might challenge twelve years of experience with pet birds as an insufficient basis from which to draw conclusions, especially in the absence of scientific studies. It seems perfectly reasonable, however, to offer observations and impressions based on experience. One of my observations about birds is that every species, in the wild or in the home, offers something special. The one species found in our homes that has no counterpart in the wild offers something extraordinarily special: hand-raised society finches make exceptional pets.

Sally and Vince Huntington's engaging article on hand-raised finches, "Meet the Companion Finch," that appeared in the June, 2003 issue of *BirdTalk* piqued my interest in these tiny creatures as companions. Shortly after reading this remarkably informative account of Sally's observations based on her experiences with hand-raised finches, I contacted her. As a result of my curiosity, I've become the owner of two progeny from Sally's aviary, female societies Raven and Cricket. An extraordinarily dynamic duo, they enliven and enrich each and every day.

Our day usually begins at 7:00 AM with birdsong broadcast by New Mexico's exclusively classical music station as it ushers in its morning program. Raven and Cricket respond as if the melodious sounds were reveille. The Bourke's parakeets chime in and add dimension by fluttering to attention. By the time bird breakfast is served a half hour later, Raven and Cricket have stretched, preened enough to feel presentable,

and begun the morning segment of their out-of-cage time.

## Sociability

As if living up to their name were their first priority, dancing on the top of the Bourkes' cage constitutes their first social activity. The next destinations are the dome tops belonging to the Hahn's macaw, and the widowed, olive-pied, peach-faced lovebird. Neither comes close to matching the societies' interest in socializing at this early hour. The last station on this round-robin is my shoulder from which Raven and Cricket invite a period of petting with a series of coos and chirps. As her name implies, Cricket is especially good at chirping. They both specialize in seeking attention. Then back to the Bourke's they go, and the rounding and resting ritual continues for a couple of hours until return-to-cage time or the urge to indulge in another extremely important ritual, bath time, occurs. When the brimming bath dish sitting on the cage grate beckons, the usual time to return to their cage is pre-empted by the urge to dive in. If they need a reminder of cage time, an extended forefinger accompanied by a simple "up-up" results in two hop-ups and in they go with no resistance—most of the time. Habituation helps. The closer this request is to their usual return-to-cage time the greater the success rate on the first try; however, they cooperate fully about ninety percent of the time. They are eager to please.

## Disposition and Behaviors

Other traits that characterize this duo's dispositions include their even-



tempered, cheerful nature, their extreme trust in human kindness, and their quiet, social activity, which is not at all disruptive or intrusive even in a home inhabited by other bird species. That's not to say that Raven and Cricket don't each have a favorite foreign cage to invade when the opportunity arises. When the Bourke's are free-ranging while their cage is being wiped down, tiny Raven enters their domain and makes herself very much at home. Her vigorous show of preening her snow-white plumage makes a statement about how easily she could adapt to this huge, luxurious, stainless steel cage. Interestingly, Cricket's predilection is the Hahn's macaw's domain, which is identical to the Bourkes' cage, where her brown-pearl coloration makes it difficult for me to determine her presence inside the cage when the macaw is returning.

Raven's and Cricket's behaviors are extremely engaging, entertaining, and complementary in their compatibility with each other and with me. Their

level of activity is pleasantly paced. They are eminently companionable, seeking closeness with me whenever possible. Although competition for my attention emerges at times, which reflects something about the connection between them, they seem to downplay it when their antics—mostly limited to a few beak on beak pecks—are noticed. Sometimes I notice a little shoving. It would be difficult to determine which is stronger, their bond to each other or to me. What is clear, however, is that they are highly, often preferentially interactive with me and that their bond with me is firm and enduring. The only times I've ever noticed any ripple in their trust of me is on the rare occasions that I am wearing a patterned shirt. Whether or not this is related to a preference for sameness, namely monochromatic apparel, or fear of change in routine (I'm usually going out at such times), patterns are apparently disturbing. They are a little wary of strangers, perhaps partly for the same reason.

Patterns on the computer screen present no problem, however. Raven and Cricket are laptop aficionados. Never, ever nippy, they do, however, imitate the bigger species in their interest in chewing, though it seems to be limited to the paperwork found on my desk. This temptation is facilitated by their love of my laptop and its proximity to my papers. Although I assume that the warmth of the keyboard is the primary element that determines the attraction, another kind of warmth, namely companionship, might compete favorable as the primary draw. Their interest extends to wanting to sit—often sleep—on my wrist whenever I'm typing, and to rest on the open keyboard whenever I'm not.

Behavior that these societies share with bigger species isn't limited to chewing paper. While the macaw and I have conversations in English—"Wanna bath," "Want some juice," "Is that good?," "Get on shoulder"—and most intimately in bird talk through clicks and clucks, Raven and Cricket are extremely responsive to the human voice and interact not only vocally but also physically. They fly to my shoulder when I call their names and being petted in response is apparently perceived as a huge reward. Except for repetition, praise and petting, i.e., the operant conditioning derived from everyday handling, no special effort, training or rewards, including treats, have been necessary to imprint this response or others, such as finger training. Behaviors the societies don't share with larger species include occasional moodiness, irritability, unpredictability, aggressive biting, feather picking, phobias, or screaming. Furthermore, bonding with humans isn't interrupted if societies are kept in pairs.

## Adaptability and Intelligence

Despite their shared tendency with most avian species to appreciate routines, society finches are highly adaptable. The aftermath of hurricane Katrina sent me and my flock into exile for eight weeks during which time we lived in Chincoteague Island, VA, courtesy of good friends who donated their rental property. Although all the birds coped quite well with the uprooting and three days of travel each way, Raven, an only finch at that time (a situation she seemed to enjoy), managed the transitions and adapted to her new surroundings without any sign of distress. Small size isn't the only factor to which we can attribute adaptability. True, the Bourke's were the next least disturbed

by the disruption, but the lovebird was least accepting. Again, only for Raven the move from New Orleans to Albuquerque was a piece of seedcake.

Size isn't the only determiner of intelligence either. The intelligence of society finches, though insufficiently studied, is also probably underappreciated. Their vigilance—they don't miss anything—and their ability to anticipate and habituate are remarkably developed capacities. Problem solving stands out in their repertoire. If confronted with a kernel of fresh corn that is unwieldy, Cricket will place it under her foot and dissect it with surgical precision. If I want them to return to their cage, Cricket will sometimes bypass the opportunity to ride on my finger and fly ahead, arriving inside the cage before Raven, who'd rather hitchhike. No competition, of course!

## Curiosity

Raven and Cricket are inquisitive, adventurous, and involved no matter what the current activity. They seem to study situations, enjoy novelty—"eating out" in the evening, a good example, is described later—and capitalize on opportunities for attention. Like toddlers in the stage of separation-individuation called *rapprochement*, they check back periodically during their twice-a-day free flight time, landing on my shoulder or head, getting petted or talked to, then off they go.

On flashing snow-white and pearl-gray wings, the duo repeat their morning activities each evening with free-range time during cage clean-ups, BBC World News, and dinner, but without the same gusto expressed in morning rounds. Periods of repose are longer, and a tendency occurs to indulge in mini-sleepovers here and there as twilight sets

in. That's not to say they miss any opportunity to "inquire" about the activities of the other birds or that they miss any occasion to investigate what I'm doing, especially at the laptop. Eating out is a very special event, however, as is their need for involvement the upkeep of their cage. They have a need to "help" with cleaning and watch closely as I remove the very small, almost insignificant amount of chaff from their seed dish. I routinely set the dish on the apron of their cage where they then devour the freshened seed as if it were a rare feast—a daily event, but each picnic is relished as a special occasion. They love their routines, but celebrating novelty is high up on their 'to-do' list. It would be difficult to resist allowing this example of novelty to become part of their routine.

They don't resist sleep in favor of novelty, however, so an evening escort back to their cage is seldom required. Before sundown, they're usually perched for the night, side by side, waiting for the protective black cover to be lowered over their cage.


## Caretaking

To own hand-reared society finches is to live in the company of cheerful, contented, healthy, meaningfully interactive, inquisitive, intelligent creatures that clearly feel at home in the company of humans. There are many advantages to keeping society finches as pets from the point of view of caretaking as well. There is no need for wing clipping—that is, in a bird-safe household, which is a fundamental requirement. My interpretation of a bird-safe environment includes covered mirrors, drawn blinds, no human traffic that results in open doors, no range top cooking during out-of-cage time, no toxins, and no non-

bird pets. Living alone is an asset in this regard.

Societies' small, manageable size and smooth, lilted flight allows them to have plenty of exercise on a daily basis. Unlike most bird species, they can easily be kept in pairs or small groups to satisfy their need for bird companionship and still maintain their bond with humans. They are not messy. Their diet of finch seed, fresh fruits and vegetables, vitamins, grit, cuttlebone and spring water is easy to maintain as is their habit of bathing several times a day. Veterinarian visits are usually limited to periodic pedicures.

I've spoken with many bird folks who would agree with the old Pennsylvania Dutch saying, "We grow too soon old and too late smart." We often discover our ideal pet birds after considerable trial and error. If I were to limit my choice of companion birds to one species, the choice would be society finches, hands down. Their attributes exceed those of larger birds in many ways and they present none of the problems so often encountered particularly with hookbills. Based on my experience with society finches, there is only one observation that I consider a disadvantage to keeping them as pets: their life spans are painfully short.



## NFSS By-Laws (Revised 2008)

**Mission Statement:** The National Finch and Softbill Society is dedicated to promoting the enjoyment of keeping and breeding Finches and Softbills to all interested parties, enhancing our knowledge of the proper care of these birds, encouraging breeding programs, and working with other organizations for the preservation of aviculture in this country.

### ARTICLE 1: NAME OF THE ORGANIZATION

This organization shall be known as the National Finch and Softbill Society. It shall also be known in a more casual manner as "NFSS", hereafter known as the Society.

### ARTICLE 2: STATUS

The National Finch and Softbill Society, is a nonprofit organization as described in section 501(C)(3) of the Internal Revenue Code. The fiscal year of the Society shall be January 1st, through December 31st.

### ARTICLE 3: HOME OFFICE

The principal office of the Society shall be that of the Treasurer or as otherwise specified by the Board of Directors and so publicized in the Society Journal. This address will be the official address for communicating with the Society and thus shall remain as static as possible.

### ARTICLE 4: MEMBERSHIP AND DUES

#### Paragraph One

The dues for membership in the Society shall be determined by the Board of Directors.

#### Paragraph Two

Membership is available to single members as well as dual members. Dual means any two individuals residing at the same address. Any dual membership will receive only one copy of a NFSS publication; however, dual members will count as two individual votes in regard to Society elections or other business. Dual members shall record

their vote in a way as then adopted by the Society

#### Paragraph Three

Junior membership will be available at a reduced rate determined by the Board to any applicant under the age of sixteen.

#### Paragraph Four

If a member's dues remain unpaid beyond the twelve month membership period, said membership shall cease. Should a member's membership cease and be renewed at a later date, the membership shall begin at that payment date. To retain the members membership number and related data, said membership must be renewed within (60) sixty days of expiration.

#### Paragraph Five

Membership in the Society is a privilege. Any member who misrepresents the Society, holds Society property without authorization, or in any way is injurious to this Society as defined as, but not limited to, violating the bylaws or making a flagrant action against the good of the Society, may lose his/her privileges of membership, and receive a prorated refund of his/her unused dues. In order to cause action under this paragraph, a member must file a deposit of twenty-five dollars (\$25.00) with the Society Treasurer, along with papers, which shall support a claim against a member of this Society. Such claim shall be taken up by the Board of Directors. If the claim is ruled legitimate and results in the removal of a member, the claimant will receive his/her deposit back. If a claim is determined by a majority of the Board not to meet it's then criteria, the deposit shall be forfeited by the claimant.

#### Paragraph Six

Affiliated clubs are not members, but are affiliated for the purpose of promotion and recognition by the way of awards for exhibitions. NFSS will publicize show dates and results for affiliates in the official Journal of the Society as then prescribed by the Board of Directors. Affiliates can not vote in elections but do receive a copy of the society journal. Types of awards and affiliation costs will be determined by the Board of Directors."

## ARTICLE 5: TERM OF OFFICE, ELECTIONS, OFFICERS

### **Term of Office**

#### Paragraph One

All officers elected by the membership of the Society shall serve for a period of two years. Each officer, elected or holding an elected position will have one vote. If a board member has assumed two positions, he/she may exercise only one vote. Appointed Manager positions, and other non-voting positions in service of the Society are created or eliminated as needed by a majority vote of the Board. The outgoing President of the Society shall be a non-voting member of the board for the following term. The Board by majority vote may reject an application for any position, either elected or appointed, if the Boards feels the applicant is not qualified to hold that position.

### **Election**

#### Paragraph Two

Elections will be held every two years, with the results announced at the annual membership meeting or as maybe occasioned by death or removal of an officer (note paragraph 5 below). Election ballots, either separate or included in the

official journal of the Society, shall be mailed at least forty five (45) days prior to the date that ballots must be returned by mail. This date shall be determined for each election by the Board of Directors. Any such ballot be will counted by at least two members of the Society and one witness as pre-approved by the Board of Directors, or an accounting firm selected by the Board of Directors. Ballots will be counted in sufficient time for the results to be announced at the general membership meeting. An officer is elected by receiving the greatest number of votes cast for that office. In the case of a tie in any election result, the tie will be broken by a majority vote of the Board of Directors.

#### Paragraph Three

The Board of Directors shall appoint a Nominating Committee at the 2nd Quarter meeting consisting of at least three members, who must produce a slate of officers for the election. The committee shall produce at least one name, and not more than three names for each office by August 1st. A write-in space must be allowed for each office on the ballot. Nominees must be at least 18 years of age when nominated and a current member of the Society and may not run for more than one voting position on the Board of Directors. A presently elected officer may temporarily assume the duties of another officer at the direction of the Board of Directors and in accordance with the Backup Officers document and other provisions of the By-laws. The nominating committee is responsible for producing the ballot and sending it to the NFSS President and the editor of the NFSS Journal for printing and mailing. Should submission of more than three names be received for any office, they will be presented to the Board, and the Board will select the

three most qualified applicants for each position.

#### Paragraph Four

All elections of this Society shall be by secret ballot only. Ballots will be counted by no less than two members of the society and one witness as pre-approved by the Board of Directors or a counting firm selected by the Board of Directors.

#### Paragraph Five

In the event an Officer, either elected or appointed, dies, resigns, or is removed, the Board may appoint a Pro Tem Officer. If less than 180 days remain until the next regularly scheduled election the Pro Tem Officer will serve until that time. If more than 180 days remain until the next regularly scheduled election, the Pro Tem officer will serve until a special election is held, such period not to exceed 180 days or the publication of the next published Journal, following the 180 day limit.

### **Elected Officers**

#### Paragraph Six

President – The President of NFSS shall preside over all Board of Directors meetings, annual membership meetings, and attend to the day to day operations of the Society. He/she shall abide by the bylaws of the Society, and coordinate and delegate the activities of the other officers of NFSS.

#### Paragraph Seven

First Vice-President (Education) – Shall fill the position of the President in absentia. Shall be first in succession to fill the position of the President should the President be unable to fulfill his/her term, in accordance with all other terms of the by-laws. The First Vice-President

coordinates the activities of, and is responsible for, all Regional Vice-Presidents and will coordinate the educational programs of the Society. The First Vice-President also approves any checks made payable to the President.

Paragraph Eight

**Second Vice-President (Publications)** – Shall be second in succession to fill the position of President. The Second Vice-President shall chair the publishing committee and is responsible for all publications produced by the Society both in print and electronic media. This officer may also supervise the NFSS Web Site. The Second Vice-President additionally supervises the Advertising and Promotions Manager.

Paragraph Nine

**Third Vice-President (NFSS Finch/Softbill Save-FSS)** – The Finch and Softbill Save Director coordinates the activities of the NFSS Captive Breeding Program. He/she complies and assists in publishing the yearly census as well as collecting data and maintaining. Said officer shall be responsible for the forwarding of funds and reports in a timely manner to Treasurer.

Paragraph Ten

**Fourth Vice-President (Judges Panel/Standards/Research)** – This officer must be a NFSS Panel Judge as he/she will serve as the Judges Panel Director. He/she shall also chair the Research and Standards Committee and be in charge of Specie Classifications, be responsible for shows or exhibitions of the Society and maintain the records points earned by members and birds from these exhibitions. In addition, the Fourth Vice-President represents the NFSS as liaison with the National Cage Bird Show

Board and other National bird shows. Said officer shall be responsible for the forwarding of funds and reports in a timely manner to the Treasurer.

Paragraph Eleven

**Executive Secretary** – This officer takes minutes during all board meetings, including those conducted electronically on the Internet. The Executive Secretary, or designated representative, shall maintain an archive of all minutes and the Society's official documents, and assist other board members with correspondence as necessary.

Paragraph Twelve

**Treasurer** – The Treasurer shall prepare and submit to the Board at the 4th Quarter Board meeting, a budget to be approved by the Board, indicating proposed income and expenditures for the upcoming year. He/she is responsible for establishing and maintaining Society financial accounts. The Treasurer is responsible for receiving and depositing funds into those accounts, and paying the Society's debts in a timely manner. The Treasurer is required to file in a timely manner, all tax information and returns as required by our IRS 990 (501c) status. All funds, records, receipts, and expenditures for the previous year or shorter period upon relief of the Treasurer, will be reviewed by two members of the Board of Directors, not to include the current Treasurer, as appointed by the Board of Directors. The results of the review will be presented to the Board of Directors upon completion. Further an audit of the financial accounts will be completed as above, upon the removal, or resignation of any Treasurer.

Paragraph Thirteen

**Membership Director** – Shall be responsi-

ble for the receipt and processing of new and renewal memberships in the Society and for the maintenance of the NFSS Membership data base and it's confidentiality. Said officer shall be responsible for the forwarding of funds and reports in a timely manner to the Treasurer.

#### Paragraph Fourteen

Affiliate/Awards Director – Shall be responsible for club affiliations, selection of clubs hosting Regional Shows and for the processing of awards for NFSS sanctioned shows and annual awards for the Society. Said officer shall be responsible for the forwarding of funds and reports in a timely manner to the Treasurer.

#### Paragraph Fifteen

Band Secretary – Shall be responsible for the ordering and issuance of official numbered closed bands in accordance with the policy of the Society, and maintaining the NFSS Band Secretary's permanent band records. Said officer shall be responsible for the forwarding of funds and reports in a timely manner to the Treasurer.

#### Paragraph Sixteen

Finchshop Director – Shall be responsible for the inventory and sales of merchandise offered to the general public. He/she must receive and process customer orders, order from vendors, and work with the NFSS Journal editor and the Web-master to update the FinchShop Catalog as needed. New products must also be sought and recommended to the Board of Directors for approval. Said officer shall be responsible for the forwarding of funds and reports in a timely manner to the Treasurer. Any Society inventory must be maintained in good order and forwarded in a timely manner upon resignation or when a

newly appointed director had been appointed.

#### Paragraph Seventeen

Regional Vice-Presidents – Shall be responsible for encouraging membership and club affiliation in the Society within the region in which he/she resides. Regional Vice Presidents are responsible to the First Vice-President and will serve as part of the Education Committee. Regional Vice Presidents are encouraged to attend the Regional Show of their area and hold at least one membership meeting annually within their region. They will assist the Legislative Liaison by keeping abreast of legislative activity within their region that could affect NFSS and it members, and report any activity. Regional Vice Presidents must report quarterly to the Board of Directors, what activities they have taken part in, or sponsored on behalf of NFSS.

### **Appointed Officers**

#### Paragraph Eighteen

NFSS JOURNAL Editor (responsible to the Second Vice-President and the President). He/she is responsible for all activities related to the production of the NFSS JOURNAL and it's timely delivery to NFSS members.. These include procuring articles and photographs, maintaining communication with all NFSS Board members to insure accuracy of NFSS information and forms to be included in each issue, create/edit each NFSS JOURNAL issue, deliver it to the printer in a timely manner and approve payment of a printer invoice for each issue. Said officer shall provide to the Treasurer, Board approved documentation which supports the timely delivery of the Journal to the Printer".

## Paragraph Nineteen

NFSS Web Site Manager (responsible to the Second Vice-President). He/she is responsible for maintaining and updating the NFSS Web Site.

## Paragraph Twenty

Advertising and Promotions Manager (responsible to the 2nd Vice President). Shall be responsible for seeking and collecting advertisements for the NFSS Journal and Web Site, and collecting payment for same. At the direction of the Board of Directors, he/she will place advertisements in major show and avicultural publications. The Advertising and Promotions Manager is responsible to the 2nd Vice President and will work with the NFSS Journal Editor. Said officer shall be responsible for the forwarding of funds and reports in a timely manner to the Treasurer. Said officer cooperates with Regional Vice-Presidents in the promotion of Regional shows.

## Paragraph Twenty-one

Forum Moderator (responsible to the President). Shall be responsible for writing and distributing list rules and enforcing a civil forum through moderation. Works with the Membership Director to coordinate subscription to the forum and is responsible for the unsubscription of members who continually prevent a civil forum from taking place.

## Paragraph Twenty-two

Legislative Liaison (responsible to the President). Shall be responsible along with Regional Vice Presidents, in keeping abreast of both local and national legislative activities that could effect bird owners, breeders, and exhibitors. Further, to report possible efforts that are not in our best interests, to the Board

of Directors in a timely manner. Shall be responsible for working with other local and national Avicultural organizations in protecting our right to own and enjoy our birds. Shall at Board direction, report all developments to our membership, in the way then set forth by the Board of Directors.

## Paragraph Twenty-three

American Federation of Aviculture Representative (responsible to the President) Shall be responsible for keeping the NFSS membership informed as to activities of the AFA through the NFSS JOURNAL and electronic media.

## Paragraph Twenty-four

Parliamentarian: The Parliamentarian shall be charged with interpreting the by-laws of the Society. He/She may select a committee of not more than three members to assist in resolving questions initiated by the Board of Directors. The committee's determinations will be binding. In cases where submitted issues are determined not to be covered by the NFSS by-laws, the committee will use the most recent edition of Robert's Rules of Order, in determining questions.

## Paragraph Twenty Five

The Board of Directors, may, by a majority vote, create a non-voting Board position to recognize a member's outstanding contribution to the Society.

## ARTICLE 6: BOARD OF DIRECTORS

## Paragraph One

The Board of Directors shall consist of all elected and appointed officers of the Society.

## Paragraph Two

The Board of Directors has the sole authority to conduct the business of the Society. The regularly scheduled Board meetings will be held either in person, by mail, or electronically via email online, on a quarterly basis as designated by the Board of Directors. The quarters shall be Calendar quarters beginning with the January-March quarter. The 4th Quarter Board Meeting may be started prior to the annual membership meeting and completed during the normally scheduled online meeting. The Board of Directors may not occasion a meeting without first sending a notice to all board members. Such a notice must be sent by mail or email at least ten days prior to said meeting.

## Paragraph Three

**Quorum:** If 50% of the Board is in attendance, a director's vote received by mail or email prior to the closing of the vote, shall be valid. If 50% of the Board members are not in attendance, business may be discussed but official actions may not take place. The agenda for Board meetings will be presented to the Board by the President or other designee, ten days prior to the beginning of the meeting. Additional items may be submitted to the Secretary by any Board member before the start of the meeting. The Secretary will provide the final agenda at the start of the meeting. A Board member may add an urgent item to the agenda during the meeting at the pleasure of the President.

## Paragraph Four

4.0 "Board meetings will be conducted in accordance with the by laws. Meetings will be online and attendance is required by all elected officers. Elected Board members that are unexcused from missing a meeting may be removed in

accordance with the provisions of the by laws. All Board members should make themselves available during meetings to offer comments.

4.1 An agenda will be offered, items will come up for a short period of discussion, after which motions and seconds will be entertained. During this time elected officers should monitor daily postings to the Board's Forum. If a motion is seconded, a vote will be called for. This will continue until all items on the agenda are presented or tabled for a future meeting.

4.2 Should there be electronic failures that prevent a Board member from voting, his/her vote may be accepted by email by the Secretary.

## Paragraph Five

**Emergency Board Meetings:** These may take place after a twenty-four hour email notice to all Board members, when four elected members of the Board and the President or next officer in line of ascension deem it necessary. A quorum of 50% of the elected Board is required to hold an Emergency Board meeting. During an emergency meeting of the Board, no action may be taken on the removal of an officer or on an amendment to these bylaws.

## Paragraph Six

Any officer of the Society found by the Board to be injurious to the Society, as defined in, but not limited to, the Membership Article 4 Paragraph 5, may be removed from office by a two thirds vote of all directors. A written complain against said officer must be signed by at least two Board members and must be received by the President by certified mail only in order to be considered by the whole Board.

## Paragraph Seven

The Board of Directors shall not be personally liable for the debts, liabilities, or other obligations of the corporation. No part of the income or assets of this corporation shall be used to the benefit of any private individual or member, unless specifically authorized by provisions of the by-laws, or by vote of the Board of Directors. Any monies authorized will be for the sole purpose of conducting NFSS business. This Society shall have no capital stock, its object and purpose being solely of a benevolent character, and not for individual pecuniary gain or profit to its members.

## Paragraph Eight

The President or Board of Directors may ask for or accept volunteers to fill positions for the completion of work needed by the Society. Volunteers that hold positions that are not elected or listed as department heads in the By-laws will not be required to be on the Board of Directors and may not have to take part in Board meetings.

## ARTICLE 7: COMMITTEES

## Paragraph One

The President or Board of Directors may form a committee for the purpose of carrying out the goals and administration of the Society. Standing Committees may include, but are not limited to the following: Show Committee, Publishing Committee, Research Committee, Judge's Panel, Standards Committee, Education Committee and Finch Save Committee. Committees may be established or disbanded as needed.

## Paragraph Two

Show Committee: The Show Committee, chaired by the Fourth Vice-President, shall be responsible for all activities

required to achieve the Society's participation in National level exhibitions.

## Paragraph Three

Publishing Committee: The Publishing Committee, chaired by the Second Vice-President, shall assist in the responsibility for the Society Web site, all publications and printed materials of this Society. The committee shall include but is not limited to the Second Vice President, the Journal editor, the Advertising Director and the Web site Manager.

## Paragraph Four

Research Committee: Shall conduct research on a given subject at the pleasure of the Board of Directors, and will assist members of the Society with matters of avicultural interest.

## Paragraph Five

Education Committee: This committee will assist its chairman, the First Vice-President, in developing educational programs for the members of this Society. The membership of this Committee shall include the Regional Vice Presidents.

## Paragraph Six

Standards Committees: The Standards Committees shall work with the Judges Panel and other interested parties in an ongoing effort to establish Standards of Perfection for individual species.

## Paragraph Seven

7.0 Judges Panel: Shall consist of all approved judges in accordance with the standards set forth by the Society. The procedure for nominating a judge for the Judges Panel shall consist of a written application by the potential judge, who is a current member of the Society. Nomination to the Judges Panel may

not take place until the potential judge has completed testing and apprenticeship under the formula as then required by the Board of Directors of the Society. Said apprentice must be nominated by at least two of the judges that the apprentice, apprenticed under.

7.1 Final approval of a new judge shall be by the Board of Directors. This will consist of a majority vote of the Board after verification from the Judges Panel Chair that the requirements have been completed. All associated paperwork, including the test will be retained by the Judges Panel Chair. If the Board deems necessary, it may review copies of all paperwork in the apprentice process, excluding the test taken.

7.2 A Panel judge may be either sanctioned or removed from the Judges Panel as recommended by the director of the Judges Panel and approved by the majority of the Board in accord with the most current NFSS Judges Handbook procedures. NFSS judges may not judge a show if they are not in current with their membership and judging fees.

#### Paragraph Eight

**FINCHSAVE Committee:** The FINCHSAVE Committee shall assist the Director of the program. It shall consist of Society members designated by the Director. This Committee shall help develop and preserve policy in regard to this nationwide multi-species captive breeding program. The Committee may request funds for the administration of the FINCHSAVE program only. All funds used for the program must be authorized by the Board of Directors. All data, statistics, and information

collected for this program will remain the sole property of the Society.

## ARTICLE 8: MEMBERSHIP MEETING

### Paragraph One

The Society shall have an annual membership meeting held in conjunction with the National Show of the Society.

### Paragraph Two

There is no Board of Directors meeting during the general membership meeting. Therefore no motions may be made and no votes taken as no official business is conducted.

### Paragraph Three

The annual membership meeting of the Society shall consist of, but is not limited to, a State of the Society report given by the President or his/her representative, the Treasurer or appointed representative will report on our year to date financial condition and possible suggestions for the future budget year, awards presentation, announcement of election results, if applicable and a longer more casual discussion period when members may make their views known to the Board of Directors.

### Paragraph Four

Regional meetings may be held at the direction of the Regional Vice-Presidents. Official business is not conducted at regional meetings. These meetings are for the general membership of the Society and are primarily to discuss ideas which may be presented to the Board of Directors at a later time. These meetings may also sponsor educational programs for the membership.

ARTICLE 9: DISSOLUTION

Paragraph One

Should it become necessary to dissolve the Society all properties of the Society shall be sold or auctioned off, as determined by the Board of Directors. After all debts of the Society have been fully paid, the remaining monies of the Society shall be given to a non-profit avicultural organization as determined by the Board of Directors.

Paragraph Two

No part of the net earnings or the Treasury of the Society shall accrue to the benefit of or be distributed to members, officers, or other private persons upon dissolution.

ARTICLE 10: AMENDMENTS TO THE BYLAWS

Paragraph One

Proposed amendments to the bylaws must be sponsored by at least two members of the Society and received by the

President by certified mail only. Any properly submitted by-law change that is considered by a vote of the majority of the Board members to not be in the best interest of the Society as a whole, may be denied consideration.

Paragraph Two

Proposed amendments to the bylaws must be published in Journal of the Society at least 30 days prior to the vote.. Any amendment to the bylaws of this Society must be approved by two-thirds of those responding. Any such ballot will be counted by at least two members of the Society and one witness as pre-approved by the Board of Directors, or an accounting firm selected by the Board of Directors.

ARTICLE 11: PARLIAMENTARY AUTHORITY

All matters of the Society will be conducted in accordance with the by-laws or Robert's rules of order as described in Article 5, paragraph 24.

# NFSS Bands

*Paula Hansen, NFSS Band Secretary*

Plastic Bands are a good way to learn to band your birds. They are not permanent and can be removed once a bird is sexed or sold. Each string contains 10 bands of one color. They come with a tool to assist in placing the band on properly. Open the plastic band wide enough to slip the bird's leg in. Don't over extend the plastic when widening with the tool, this may cause the band not to close completely. Detailed instructions are provided. Banding birds with split plastic bands for identification of breeder isn't practical as they are removable, it doesn't prove the year the bird fledged, and isn't recognized for birds to accumulate points in a NFSS Show. However, the breeder showing will acquire points using colored plastic bands. Using single color split bands identifies family groups from a distance or that chick who lost its closed band prior to fledgling.

You can apply the plastic bands any time. Some use the split plastic bands to learn to band birds later with closed bands. Getting used to holding chicks is the trick. Some don't even use the tool we send to apply the plastic bands; instead they practice the closed band technique using plastic bands. This avoids having to squeeze the plastic band shut in addition to learning the closed band technique. Others only band the offspring with the plastic bands so they do not sell off their breeding stock by mistake. They also use the colors to help in sexing their birds. Placing different colored bands on each chick in a clutch can help visually identify which bird is the male/female when trying to sex each chick. Some place bands on left

leg and other clutches right leg this too helps to identify one family group different clutches during the year.

Upon pairing unrelated birds, the split plastic bands can be removed and reused.

Closed bands remain on the bird for life. Normally bands are applied to chicks at ages 10 to 16 days or 8 to 10 depending on the species. NFSS has a recommended size for closed bands for each species. They appear in each journal and on the NFSS website. Use caution when banding your birds. Don't squeeze the bird's body and have someone assist you when learning to close band your bird. The band should be slightly loose to move up and down the leg of the bird but fit well enough not to slip past the bird's ankle or knuckle. Bands should never look like a loose bracelet on the bird's leg.

All closed band orders for the new year are held until Christmas week. This is to ensure that breeders have bands just in time for early clutches. Should members need bands immediately use the NFSS website to order, e-mail the band secretary or call. Check the NFSS website at: <http://nfss.org> for color availability or email me at: [bands@nfss.org](mailto:bands@nfss.org).

Applying closed bands can be a scary experience for the first timer. Have a friend help you. Take your time. Sit down at a table do not stand in the middle of the room.

Prepare before you pick the chick up —place a cloth down on the surface below your hand or where you will

be banding the bird. Should you drop the band you can easily retrieve it and not look for hours where it rolled and bounced off to. I can't tell you how many times I have done that. You need a toothpick and a dab of lubricant. It can be an ointment, cream or KY jelly. I'll explain below.

Pick up the chick with one hand and make a fist with the other hand. Turn your fist in an upward position. (mental picture -knuckles down & fingers up.) Open your fingers & place the chick in the palm of your hand, the birds head facing you, right side up in the cup of your hand, not upside down. Cup your hand more. This will wedge the chicks head in a pocket in your palm of your hand. The chick will lay quietly. Now close your 3 fingers lightly over the chick. This will make a dark environment for the chick and it will lay still, warm and quite. With your free hand maneuver the chicks leg. It should be held under your thumb and on top of your pointing finger. (mental picture-like holding the remote when changing channels on the TV.) Toes should be exposed past the thumb pointing away from you.

Notice the chicks toe receiving the band will automatically uncurl, stop wiggling, straighten, and come to a point. If it doesn't happen adjust the chick in that pocket in the palm. Check your 3 fingers covering the chick it has to be dark in your cupped palm for this technique to work! Toes will straighten. Take your time the chick is okay and warm just don't squeeze it tight.

Once you achieve a pointed 3 toes, this is where you slip the band over the 3 pointed front toes slowly & carefully. Remember finches have 4 toes of which 3 go through the ring first. That 4th(rear) toe should be lying open & flat against the chick's leg waiting for the band to slide over it and the leg at the same time. Once you slide that band on free this is where the 4th toe (it's usually the nail that gets snagged in the band) needs a little help getting free. Place the toothpick between the 4th toe and the leg lift the toe away from the leg and it will free

itself without causing any harm to the chick. Toes have very soft bone. You can practice banding using this technique with an adult bird using the split plastic bands however the adults will fuss more until you place them in that dark cup of your palm covering with the 3 fingers.

Ordering bands you can submit your order through the NFSS website using PayPal or mail-in your order. I'll receive your order and mail it out. This hopefully will ease the stress level a notch or two. Email me any time with your questions. If you are one of the late members who have babies hatching and need these fast, send me a separate email. Bands are usually mailed on Mondays or Fridays once a week.

All band orders come with instructions and membership applications. Make sure your membership is current. All orders containing closed bands are checked for the membership information. The NFSS Membership Director sends a new list monthly to the Band Secretary. Occasionally I have to ask "why" if your name doesn't appear as a member, and you will be requested to renew your membership. This may delay your order. If you are a representative of an affiliated club, this does not give you a personal membership to order closed bands. You must be an individual member.

All closed bands are registered in the Band Secretary's log book. Each string of closed bands is sequentially numbered and a string contains 10 bands. Should you wish to loan your bands to other NFSS members, contact me directly with their full name, NFSS member number, band size, and the band numbers. This is another perk for ordering NFSS Bands.

Over the past 5 years NFSS has really grown. With this growth so have the band orders. There may be times toward the end of the year when inventory runs low or completely out. I recommend bands be ordered early when possible, allow time to receive your bands. NFSS Bands are ordered 6 months in advance so the numbering is continuous, never duplicated throughout the year for any given size. There are no custom engraving available. This is how NFSS keeps the cost to its member's low and handling fee affordable. NFSS ships bands internationally.
